

# Before Departure: Israel Entry Statement

You need to fill out and submit the online form within 48 hours before the flight, the earlier the better. Without a complete form, you will not be allowed to board the flight and border control will not let you through.

You can also fill out this form on behalf of your spouse or children who have visited the same countries as you have in the last 14 days



## Itinerary

The criteria for entering isolation upon arrival in Israel are generally based on the countries that you have visited in the last 14 days



## Upon Arrival in Israel

At the end of the entry process, you will receive instructions regarding mandatory testing and isolation upon arrival in Israel, which is based on your itinerary and health status (if you have been vaccinated or if you have recovered)

## Health declaration

1. I am not a confirmed COVID-19 case;
2. I am not required to enter isolation for any reason;
3. In the last 14 days:
  - I have not been exposed to a person who must enter isolation (this is irrelevant if you are vaccinated or recovered)

- I have not displayed any COVID-19 related symptoms, or after the onset of such symptoms, I tested negative on a PCR test, or tested negative on a COVID-19 antigen test.

I acknowledge that all travelers arriving in Israel must go into isolation:

- **Full isolation** of 14 days, which can be shortened by taking a COVID-19 antigen test (for those over the age of 60 or belonging to an at-risk group - a PCR test) from day 5 of the isolation, according to the guidance;
  - **Short isolation** for 24 hours or until receipt of a negative result on the PCR test taken on arrival in Israel in the airport, whichever is earlier.
4. I have stayed outside of Israel no more than 72 hours, or I have **one of the certificates specified below** and I commit to show one of them on arrival in the airport:
    - A negative result on a PCR test taken no more than 72 hours before scheduled departure;
    - A negative result on a COVID-19 antigen test taken no more than 24 hours before scheduled departure;
    - A positive result on a PCR test or a COVID-19 antigen test taken in the 3 months before scheduled departure, provided at least 8 days have passed since the test.
    - A permission certified by the Exceptions Committee to board the flight without proof of a negative COVID-19 test result.
  5. If I, or the people traveling with me, must enter isolation, we will isolate in an accommodation at my disposal; More information on mandatory isolation
  6. I acknowledge that a false statement may be used as evidence against me in criminal proceedings;
  7. I hereby commit to not board a flight, if there is a change to one of the statements of this form.

I declare that all of the details that I have provided are true and I committed to not board the plane should any of details change

I am aware that if it transpires that I am a COVID-19 carrier, I will be required to:

- Isolate in a managed isolation facility until my recovery;
- Pay for the expenses of an ambulance to bring me to the place of isolation;
- Pay for my stay in the place of isolation.

I am aware that these are the conditions for my entry into Israel, and I accept them. I am aware that violating these conditions may lead to revocation of my permission to be in Israel or refusal of future entry into Israel for up to five years.

Confirm the declaration

I conducted an antigen test within 24 hours before departure.

I conducted a PCR test within 72 hours before departure.

Confirmation that all of the details that I have provided are true at the time of signing the declaration.
